



**In accordance with the Behavioural Code for Promotional Games of Chance, these general game conditions (hereinafter: The "General game conditions") applicable to promotional games of chance of Fashion Concept (hereinafter: the "Supplier").**

**Besides the General game conditions, Specific game conditions with regard to participation in the game in question, will apply in most cases for individual promotional games of chance. By participating in the game, the participant agrees to the applicability of the General and Specific game conditions.**

Entrants must be at least 16 years of age, unless otherwise determined in the Specific game conditions. If participation is allowed for persons younger than 16 years of age in accordance with the Specific game conditions, entrants aged under 16 years must declare to have permission from (a) parent(s) or guardian to participate in the game.

Employees of the Supplier (including subsidiary companies) and their partners and family living under one roof, are precluded from participation, as well as any persons employed by the Supplier in organisation of the game, including advertisers, sponsors or producers.

Entrants must provide correct, up to date and complete information upon participation in the game. Prior to awarding a prize, the Supplier may require a winner to provide proof of identity and a valid registration at the residential address given by the entrant.

No correspondence will be accepted regarding the results of the game and allocation of prizes.

The prizes are personal and are allocated in the name of the winner. The prizes are not transferable and cannot be redeemed for money or for other products or services. Upon refusal or non-acceptance of the prize or conditions attached to the prize, the prize will not be awarded. The Supplier is then authorised to allocate a new winner.

The prizes are awarded in the state in which they are found. The Supplier is not responsible for any visible or hidden defects to the prizes nor for any damage upon delivery (dispatch) of the prize.

The delivery of the prizes is the responsibility of the Supplier, the advertiser/sponsor or a third party named for that purpose.

The Supplier is not responsible for any problems encountered in postal or delivery companies (delays, strikes, damage or loss) in delivery of the prizes. In the event that the winner is not available to receive the prize sent by registered delivery, the winner will collect the prize at a later date (from the post office or postal agency, etc). The Supplier cannot be held

responsible if the prize is not collected by the winner or is received by an unauthorised person, nor if the postal or delivery company fails to leave behind any notification or message.

The winner can claim the prize until three months following announcement of the win. Following this period, the entitlement to the prize is cancelled. At the request of the Supplier, the winners of prizes will cooperate in promotional activities of the Supplier insofar as this may be reasonably expected of them, including publicity with regard to the prize being awarded via all media such as the radio, television and internet. There will be no financial payment for this cooperation in promotional activities.

The entrant gives permission for the use of personal data in connection with participation in the game. The Supplier may include this personal data in its database, which will be treated with confidentiality and in accordance with the Law on Protection of Personal Data.

The personal data may be used for implementation of the game and for awarding the prizes. For those purposes, the Supplier is entitled to pass on the personal data to third parties, involved in the game in question (including suppliers, advertisers, sponsors and/or producers).

The use of the prizes awarded is for the account and risk of the winners. The Supplier cannot be held responsible for the use of the prizes by the winners, on the basis of the General and/or Specific game conditions.

The Supplier is by no means liable for any damage resulting from participation in the game nor for any technical malfunctions, defects or delays with regard to participation in the game or allocation of the winner.

The Supplier is by no means responsible for possible problems or defects resulting from the use of the website and/or downloading of any components with regard to the games.

The Supplier may disqualify entrants if he is of the opinion that they have not acted in accordance with the General and/or Specific game conditions or if the entrants gain access to the game in any (other) fraudulent manner or influence the process of the game in an unfair manner.

A copy of the General and/or Specific game conditions will be provided free of charge at the request of an entrant. The General and Specific game conditions can also be read at [www.gantcitybike.nl](http://www.gantcitybike.nl).

The Supplier is entitled to amend or adjust these General game conditions and the Specific game conditions as it sees fit and without prior communication, during the duration of the game (competition period), or to discontinue, amend or adapt the game for its own reasons but without the obligation to name such reasons, without the Supplier being liable for any form of compensation towards the entrant. Amendment or adaptation of the game will be announced by the Supplier in a fitting manner (via the site, for example).

Should one or more of the General and/or Specific game conditions be(come) void or invalid, this does not affect the validity of the other conditions of the General and/or Specific game conditions.

Insofar as the General game conditions deviate from the conditions of the Specific game conditions, the Specific game conditions have prevalence.
